27 - 31	Lower Roofs	Anchors not certified as there is no safe access to the roofs. Ladder brackets to be installed to parapets with landings below them on the roof. A 2.4mt portable ladder should be installed on the main roofthis will provide users a safe and compliant method to access the lower roofs and anchors.
