Item No	Location	Recommendations
5	Main Roof	Replace static line to continue safe access along the narrow roof section.
51	Main Roof	Install grab rails for hatch and if possible, increase the ceiling hatch size or discontinue the use of the hatch.
Various	Main Roof	Due to the pitch of the roof, install additional anchors in various locations to assist in safe access to the other anchors.
